

**City of Walton**  
**Council Meeting Minutes**  
**May 14, 2019**

**Call to Order**

The Common Council of the City of Walton, Kentucky met in a regular called session on Tuesday May 14, 2019 at 7:30 p.m. with the following present: Mayor Gabe Brown. **Approval of Agenda**

**Municipal Order**

**Ordinance**

Council Member Matt Brown moved to approve the first reading of **Ordinance No. 2019-03** amending the City of Walton Code of Ordinances by creating a new section 72.08 in order to prohibit overnight parking in parking areas provided for the city’s pocket parks.
