Second reading of ORDINANCE 2019-05 OF THE CITY OF WALTON, KENTUCKY, AMENDING ORDINANCE 2013-17 BY REPEALING THE STOP SIGN LANGUAGE IN SECTION TWO THEREIN, THEREBY REQUIRING THE ELIMINATION AND REMOVAL OF THE STOP SIGNS IN BOTH DIRECTIONS ON EDWARDS AVENUE AT 231 EDWARDS, AND TO ADD LANGUAGE TO REPLACE THE STOP SIGNS WITH “SLOW” “CURVE” SIGNS OR APPROPRIATE EQUIVALENTS.

Second reading of ORDINANCE 2019-06 OF THE CITY OF WALTON, KENTUCKY, REPEALING ORDINANCE 2017-20, THEREBY RESCINDING THE REQUIREMENT TO INSTALL STOP SIGNS ON OLD STEPHENSON MILL ROAD AT THE INTERSECTION WITH CENTRAL AVENUE AND ITS PROVISION IMPLEMENTING PENALTIES FOR VIOLATIONS THEREOF; THEREBY REQUIRING THE ELIMINATION AND REMOVAL OF THE STOP SIGNS ON OLD STEPHENSON MILL ROAD AT THE INTERSECTION WITH CENTRAL AVENUE, AND THE STOP SIGN ON CENTRAL AT STEPHENSON MILL TO REMAIN.

Second reading of ORDINANCE 2019-07 OF THE CITY OF WALTON, KENTUCKY, AMENDING SECTION 150.35 OF THE WALTON CODE OF ORDINANCES BY DESIGNATING THE WALTON FIRE PROTECTION DISTRICT AS THE AUTHORITY HAVING JURISDICTION TO ENFORCE THE STANDARDS OF SAFETY AND THE OTHER PROVISIONS CONTAINED IN THAT SECTION, AND TO OPERATE A FIRE INSPECTION PROGRAM PURSUANT TO KRS 227.320; FURTHER TO REQUIRE CERTAIN ADDITIONAL LIFE AND FIRE SAFETY PRECAUTIONS, IMPROVEMENTS AND ACTIONS BY OWNERS AND OPERATORS OF STRUCTURES AND BUSINESSES IN THE CITY.
