

**CITY OF WALTON, KENTUCKY  
ORDINANCE NO. 2020-04**

**AN ORDINANCE OF THE CITY OF WALTON, KENTUCKY, AMENDING SCHEDULE I (A) OF CHAPTER 74 OF THE WALTON CODE OF ORDINANCES, IN ORDER TO PROVIDE FOR THE INSTALLATION OF STOP SIGNS IN THE AOSTA VALLEY SUBDIVISION IN THE FOLLOWING LOCATIONS: A 4-WAY STOP AT THE INTERSECTION OF AOSTA VALLEY DRIVE AND CHARDONNAY VALLEY; AND A 3-WAY STOP AT THE INTERSECTION OF VENETO DRIVE AND LA SALLE COURT.**

**WHEREAS**, the City Council of the City of Walton, Kentucky deems it necessary for the health and safety of its citizens and visitors, and to eliminate potential hazardous situations for motor vehicles traveling in the Aosta Valley subdivision, to authorize stop signs therein;

**NOW, THEREFORE**, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WALTON, KENTUCKY AS FOLLOWS:

**SECTION ONE**

Schedule I (A) of Chapter 74 of the City of Walton Code of Ordinances is hereby amended as follows:

**A. Stop signs shall be installed in all directions at the intersection of Aosta Valley Drive and Chardonnay Valley, in order to result in a four-way stop at that intersection.**

**B. Stop signs shall be installed in all directions at the intersection of Veneto Drive and La Salle Court, in order to result in a three-way stop at that intersection.**

**C. The stop signs shall be enforced in accordance with KRS 189.330.**

**SECTION TWO**

This Ordinance shall take effect and shall be in full force on January 1, 2021, and after its enactment and publication as required by law.

**SECTION THREE**

All ordinances or parts of any ordinances in conflict herewith, to the extent of the conflict, if any, are hereby repealed.

**SECTION FOUR**

If any sentence, clause, section or part of this ordinance or the application thereof to any particular situation is, for any reason, found to be unconstitutional, illegal or invalid, the invalidity of any provision of this Ordinance shall not affect the validity of any other provisions hereof, and such other provisions shall remain in full force and effect as long as they remain valid in the absence of that provision determined to be invalid.

**SECTION FIVE**

This ordinance may be read and published in summary form.
