1. **Ordinance 2023-13 Second Reading** AN ORDINANCE OF THE CITY OF WALTON, KENTUCKY, AMENDING CHAPTER 92 OF THE CITY OF WALTON CODE OF ORDINANCES, IN ORDER TO PROVIDE THAT THE DEPOSITING OF LEAVES, GRASS CLIPPINGS AND OTHER YARD WASTE ONTO SIDEWALKS, STREETS AND STORM SEWERS IS PROHIBITED AS A PUBLIC NUISANCE; AND PROVIDING FOR CIVIL FINES FOR PUBLIC NUISANCES. Dan Martin made a motion to table Ordinance 2023-13. Terri Courtney seconded the motion. Upon roll call the following Council members voted “yes”: Rose Beach, Amy Long, Matt Brown, Dan Martin, and Terri Courtney.
