

**CITY OF WALTON, KENTUCKY
ORDINANCE NO. 2024-01**

AN ORDINANCE OF THE CITY OF WALTON, KENTUCKY, AMENDING SECTION 91.40 OF THE CITY OF WALTON CODE OF ORDINANCES IN ORDER TO PROHIBIT ATV'S, DIRT BIKES, MOTORCYCLES AND GO CARTS IN ADDITION TO HORSES ON SIDEWALKS IN THE CITY; AND PROVIDING FOR PENALTIES AND CIVIL FINES FOR VIOLATIONS.

BE IT ORDAINED BY THE CITY OF WALTON, KENTUCKY AS FOLLOWS:

SECTION ONE

Section 91.40 of the City of Walton Code of Ordinances is hereby amended to read as follows:

§ 91.40 [ALLOWING] PROHIBITING HORSES, ATV'S, DIRT BIKES, MOTORCYCLES AND GO CARTS ON SIDEWALKS.

A. It shall be unlawful for any owner or possessor of a horse, pony, or other similar sized and shaped animal, **OR ANY ALL TERRAIN VEHICLE (ATV), SIDE-BY-SIDE, DIRT OR MINI-BIKE, MOTORCYCLE OR GO CART, OR SIMILAR VEHICLE OR CONVEYANCE DEVICE,** to cause or allow the same to be ridden, walked, or to be on or about any sidewalks or paths similarly used by people and citizens of the city anywhere within the city limits.

B. IN ADDITION TO ANY OTHER PENALTIES FOR VIOLATIONS OF THIS SECTION, WHOEVER VIOLATES THIS SECTION SHALL BE SUBJECT TO THE CODE ENFORCEMENT AND CIVIL FINES AND OTHER PROVISIONS OF THIS CODE OF ORDINANCES AS SET FORTH IN §§ 34.65 TO 34.77 AND AMENDMENTS THERETO.

SECTION TWO

All ordinances or parts of any ordinances in conflict herewith, to the extent of the conflict, if any, are hereby repealed.

SECTION THREE

If any sentence, clause, section or part of this ordinance or the application thereof to any particular situation is, for any reason, found to be unconstitutional, illegal or invalid, the invalidity of any provision of this Ordinance shall not affect the validity of any other provisions hereof, and such other provisions shall remain in full force and effect as

long as they remain valid in the absence of that provision determined to be invalid.
