CITY OF WALTON, KENTUCKY ORDINANCE NUMBER 2024-11

AN ORDINANCE OF THE CITY OF WALTON, KENTUCKY, GRANTING A COMPETITIVE NONEXCLUSIVE FRANCHISE TO **SPECTRUM MID-AMERICA**, LLC D/B/A/**CHARTER** COMMUNICATIONS, INC. ("CHARTER"), FOR THE ERECTION, LAYING **OPERATION AND MAINTENANCE OF TELEVISION TRANSMISSION AND** DISTRIBUTION FACILITIES AND APPURTENANT EQUIPMENT IN, ALONG AND ACROSS THE PUBLIC WAYS, ROADS, STREETS, ALLEYS AND OTHER PUBLIC PLACES IN THE CITY OF KENTUCKY, FOR FURNISHING AND SELLING CABLE AND RELATED SERVICES AN PRODUCTS BY MEANS OF SAID FACILITIES: AND AUTHORIZING AND DIRECTING THE MAYOR, CITY CLERK, AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN APPROPRIATE FRANCHISE AGREEMENT TO CARRY OUT THE TERMS OF THIS ORDINANCE.

WHEREAS, the City of Walton, Kentucky ("City") wishes to ensure that the provision of cable television and related services and products continues to be furnished to its citizens in a reliable, affordable and efficient manner;

WHEREAS, the City has adopted Ordinance 2024-08 which created nonexclusive competitive franchises ("Franchises") to use the City's public rights-of-way, public streets, ways, alleys and other public places in order to facilitate the provision of cable television and related services and products;

WHEREAS, Ordinance 2024-08 further provided that the Franchises created by the Ordinance shall be bid in accordance with the applicable requirements of the Constitution of the Commonwealth of Kentucky and Chapter 424 of the Kentucky Revised Statutes, as well as any applicable City Ordinances;

WHEREAS, the City advertised for cable television and related franchise bids according to law and Spectrum Mid-America, LLC d/b/a/ Charter Communications, Inc. ("CHARTER") submitted a nonexclusive competitive bid to the City for franchise rights to provide cable television and related services and products throughout the City;

WHEREAS, the City has determined that CHARTER's cable system franchise bid is reasonable in light of community needs, and that CHARTER has the ability to effectuate its franchise application;

WHEREAS, the City has determined that CHARTER's competitive cable television and related services and products franchise bid meets the community needs and interests of the City of Walton and its citizens; and

WHEREAS, the public has had adequate notice and opportunity for comment.

NOW, THEREFORE, BE IT ORDAINED as follows:

SECTION 1: A nonexclusive competitive cable television and related services and products franchise is hereby granted to CHARTER in order to use the City's public rights-of-way, public streets, ways, alleys and other public places in order to provide cable television and related services and products throughout the City via its cable system.

SECTION 2: The City's Mayor, City Clerk, and City Attorney are hereby authorized and directed to work out the terms of the cable television and related Franchise Agreement with CHARTER; and the Mayor is authorized to execute it, all according to the framework the bidding requirements and to CHARTER's bid as submitted to the City and to such additional terms and provisions that are fair and reasonable to the City, to CHARTER, and to the customers of CHARTER, pursuant to KRS 96.010. The Franchise Agreement shall take effect upon execution and according to the terms of the Agreement.

SECTION 3: All ordinances or parts of ordinances in conflict with the provisions of this Ordinance are hereby repealed.

SECTION 4: Should any section, clause, line, paragraph, or part of this Ordinance be held unconstitutional or invalid for any reason, the same shall not affect the remainder of this Ordinance or the Franchise Agreement, as applicable.

SECTION 5: This Ordinance shall become effective from and after its passage and publication.

SECTION 6: This ordinance may be read and published in summary form.
