CODE ENFORCEMENT 101

THE ROLE AND IMPORTANCE OF CODE ENFORCEMENT OFFICERS:

A code enforcement officer is a sworn-in inspector and investigator employed by the city and specializes in the prevention, detection, and enforcement of violations of city ordinances and property maintenance code. The officer ensures that businesses and people are in compliance with public health, safety, public works, building standards, and more. In short, code enforcement protects the community by regulating entities that are breaking property maintenance code and city ordinances. For example, on a daily basis, a code enforcement officer could find themselves performing inspections, carrying out routine duties in support of a city's ordinances Internation Property Maintenance Code, and responding to citizen inquiries or complaints. Code enforcement officers are a necessity to every single city and county jurisdiction.

One of the biggest myths about code enforcement officers is that we strive to hand out as many citations as possible to make money for the city. This couldn't be further from the truth. The first action is usually a written notice of violation or a simple conversation, allowing a reasonable amount of time to make corrections before a citation is issued. Another myth you may have heard is that code enforcement officers pick and choose the complaints they investigate. Every single complaint is investigated whether driving past the location in question or making personal contact, a record is kept of the investigation, and the investigation's outcome is documented to ensure all items are inspected. Common code violations we see and what we need YOU to correct:

1.Tall arass. City Ordinance doesn't allow overgrowth whatsoever and grass must be kept 8 inches or lower.

2. Vehicles parked in grass, on sidewalks, in cul-de-sacs, parked the wrong direction on the streets, or parked in no parking areas and parking in marked fire lanes. 3.In-operable or un-registered vehicles parked on city streets or in driveways. Also, vehicles in a state of major repair or dis-repair in driveways, city streets or on property. 4.RVs, travel trailers, boats or other trailers parked in driveways or on city streets. Some trailers depending on size can be parked behind the front line of a home or to the rear on a hard surface.

5.Mold covered siding.

6.Accumulation of trash and other household items outside the home, on porches and in driveways. 7.Broken windows, missing siding, damaged soffits and properties in disrepair 8.Chickens. No roosters are permitted and you may have only 6 hens kept inside a coop in the backyard.
