



**CITY OF WALTON, KENTUCKY
ORDINANCE NO. 2025-06**

**AN ORDINANCE OF THE CITY OF WALTON, KENTUCKY,
AMENDING SECTION 50.55 OF THE CITY OF WALTON
CODE OF ORDINANCES IN ORDER TO REVISE THE FEES
FOR CONNECTING TO THE CITY'S WATER SUPPLY
SYSTEM.**

BE IT ORDAINED BY THE CITY OF WALTON; KENTUCKY AS FOLLOWS:

SECTION ONE

Section 50.55 of the City of Walton Code of Ordinances is hereby amended to read as follows:

§ 50.55 WATER AND SEWER CONNECTION FEES.

(A) Meter installation fees shall be as follows:

<i>DESCRIPTION</i>	<i>INSIDE CITY LIMITS</i>	<i>OUTSIDE CITY LIMITS</i>
3/4" meter	<i>[\$900] \$1,300</i>	<i>[\$900] \$1,300</i>

******Exception – Commercial/Industrial customers, see 19.******

(B) Tap-on charges shall be as follows:

Residential – ***[\$300.00] \$450.00***
Commercial/Industrial – ***[\$500.00] \$700.00***

(C) (1) Sewer connections fees shall be as follows:

Single Family \$1,000
2 or 3 Family \$1,500
4 or more Family \$1,500
Business \$1,500

(2) Sewer tap fees shall be deposited into the depreciation fund.

(D) (1) Prices for 1-inch to 2-inch are as follows

Service Deposit \$150.00

Water Tap \$750.00

Sewer Tap \$1,500.00

(2) 1-inch service or larger must be installed by a licensed plumber and inspected by the City water department.

SECTION TWO

All ordinances or parts of any ordinances in conflict herewith, to the extent of the conflict, if any, are hereby repealed.

SECTION THREE

If any sentence, clause, section or part of this ordinance or the application thereof to any particular situation is, for any reason, found to be unconstitutional, illegal or invalid, the invalidity of any provision of this Ordinance shall not affect the validity of any other provisions hereof, and such other provisions shall remain in full force and effect as long as they remain valid in the absence of that provision determined to be invalid.
