**Resolution 2025-09** - A RESOLUTION OF THE CITY OF WALTON, KENTUCKY, REQUESTING THE BOONE COUNTY PLANNING COMMISSION TO PREPARE A ZONING TEXT AMENDMENT TO THE WALTON ZONING REGULATIONS, SECTION 35.04, TO HOLD A PUBLIC HEARING, AND TO MAKE A RECOMMENDATION RELATIVE TO RELAXING THE REGULATIONS ALLOWING FOR THE OPERATION OF FOOD TRUCKS AS A PERMITTED USE, FOR LONGER TIME PERIODS, AND MORE FREQUENTLY, WHILE STILL REQUIRING HEALTH DEPARTMENT LICENSING AND ANY APPLICABLE OCCUPATIONAL LICENSE.
