

# CITY OF WALTON, KENTUCKY ORDINANCE NO. 2025 - 13

AN ORDINANCE OF THE CITY OF WALTON, KENTUCKY, AMENDING SECTION 150.35 THEREIN, AND CREATING SUBSECTION (G) THEREIN, IN ORDER TO ESTABLISH AN INSPECTION AND PERMIT PROGRAM FOR MOBILE FOOD SERVICE, TO INCLUDE FOOD TRUCKS, FOOD TRAILERS, FOOD CANOPIES AND TENTS; AND DELEGATE THE AUTHORITY TO WALTON FIRE DISTRICT'S INSPECTION BUREAU TO CONDUCT LIFE SAFETY INSPECTIONS IN ACCORDANCE WITH THE "KENTUCKY STANDARDS OF SAFETY" (CHAPTER 10 TITLE 815 KENTUCKY ADMINISTRATIVE REGULATIONS), AND TO ISSUE THE PERMIT UPON SUCCESSFUL INSPECTION.

**BE IT ORDAINED** BY THE CITY COUNCIL OF THE CITY OF WALTON, KENTUCKY AS FOLLOWS:

#### **SECTION ONE**

Section 150.35 of the City of Walton Code of Ordinances is hereby amended as follows by creating subsection (G) therein:

## § 150.35 STANDARDS OF SAFETY ADOPTED/FIRE DEPARTMENT AUTHORITY/OTHER LIFE SAFETY REQUIREMENTS.

[Subsections (A) thru (F) shall remain unamended]

- (G) There is hereby established an inspection and permit program for mobile food service, to include food trucks, food trailers, food canopies and tents.
- (1) The City hereby delegates the authority to Walton Fire District's Inspection Bureau to conduct life safety inspections in accordance with the "Kentucky Standards of Safety" (Chapter 10 Title 815 Kentucky Administrative Regulations and to issue the permit upon successful inspection.
  - (2) The program shall consist of two permit types:

#### (a) Short Term Food Service (0-3 days):

- (ii) City sponsored events;
- (iii) Church festivals: and
- (iv) Businesses having special events.

The inspection procedure shall consist of a "self" life safety inspection, followed by Walton Fire District's Inspection Bureau confirmation of completion the day of the event. A temporary marking / tagging validation of "self-inspection" will be issued.

## (b)Long Term Food Service (greater than 3 days):

The Inspection procedure shall require a life safety inspection of the mobile food truck, trailer by Walton Fire District's Inspection Bureau according to Exhibit "A", which is

attached hereto and incorporated herein by reference. Once compliant, followed up with an operational inspection upon issuance of a City of Walton "Mobile Food Service" permit.

## **SECTION TWO**

This Ordinance shall take effect and shall be in full force upon adoption and publication according to law.

## **SECTION THREE**

All Ordinances or parts of any Ordinances in conflict herewith, to the extent of the conflict, if any, are hereby repealed.

## **SECTION FOUR**

If any sentence, clause, section or part of this Ordinance or the application thereof to any particular situation is, for any reason, found to be unconstitutional, illegal or invalid, the invalidity of any provision of this Ordinance shall not affect the validity of any other provisions hereof, and such other provisions shall remain in full force and effect as long as they remain valid in the absence of that provision determined to be invalid.

#### **SECTION FIVE**

This Ordinance may be read and published in summary form.
