

CITY OF WALTON, KENTUCKY **ORDINANCE NO. 2025-16**

AN ORDINANCE OF THE CITY OF WALTON, KENTUCKY, AMENDING CHAPTER 74 OF THE CITY OF WALTON CODE OF ORDINANCES, ENTITLED TRAFFIC SCHEDULES, BY CREATING SCHEDULE IV THEREIN IN ORDER TO PROHIBIT HEAVY TRUCK TRAFFIC FROM ENTERING AND EXITING THE WEST ENTRANCE OF TOWNE CENTER DRIVE FROM AND TO ITS INTERSECTION WITH MARY **GRUBBS HIGHWAY.**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WALTON, KENTUCKY AS FOLLOWS:

SECTION ONE

Chapter 74 of the City of Walton Code of Ordinances, entitled TRAFFIC SCHEDULES, is hereby amended by creating SCHEDULE III therein as follows:

Schedule

- I. Stop intersections
- II. Prohibited construction traffic
- III. One-way streets
- IV. Prohibited heavy truck traffic

SCHEDULE IV. PROHIBITED HEAVY TRUCK TRAFFIC.

- (A) Heavy truck traffic (including semi-trucks and trailers, construction vehicles, large commercial vehicles, and equivalent) shall be prohibited from turning in to or out of the west entrance of Towne Center Drive (across from School Road) from and to its intersection with Mary Grubbs Highway. Such heavy truck traffic shall use the east entrance of Towne Center Drive (across from Beatrice Avenue).
- (B) Any person, firm, corporation or company who violates any prohibition in this Schedule IV for which another penalty is not specifically provided may be cited by law enforcement and shall be fined not less than \$100 nor more than \$500 for each offense.e
- (C) Also, any violation of the heavy truck prohibition contained in this Schedule IV is hereby classified as a civil offense, pursuant to KRS 65.8808 and Sections 34.65 through 34.77 of this code.
- (1) Such classification as a civil offense is intended, and shall be construed, to provide an additional or supplemental means of obtaining

compliance with these provisions, and nothing contained herein shall prohibit the enforcement of these provisions by any other means authorized by law.

(2) Civil fines for violations of this Schedule IV shall be as set forth in Section 34.74 of this code and amendments thereto.

(3) Each incidence of a violation shall be considered a separate offense without issuance of a separate citation.

SECTION TWO

This Ordinance shall take effect and shall be in full force upon adoption and publication according to law.

SECTION THREE

All ordinances or parts of any ordinances in conflict herewith, to the extent of the conflict, if any, are hereby repealed.

SECTION FOUR

If any sentence, clause, section or part of this ordinance or the application thereof to any particular situation is, for any reason, found to be unconstitutional, illegal or invalid, the invalidity of any provision of this Ordinance shall not affect the validity of any other provisions hereof, and such other provisions shall remain in full force and effect as long as they remain valid in the absence of that provision determined to be invalid.

SECTION FIVE

This ordinance may be read and published in summary form.
