Second Reading: Ordinance 2025-13 - AN ORDINANCE OF THE CITY OF WALTON, KENTUCKY, AMENDING SECTION 150.35 THEREIN, AND CREATING SUBSECTION (G) THEREIN, IN ORDER TO ESTABLISH AN INSPECTION AND PERMIT PROGRAM FOR MOBILE FOOD SERVICE, TO INCLUDE FOOD TRUCKS, FOOD TRAILERS, FOOD CANOPIES AND TENTS; AND DELEGATE THE AUTHORITY TO WALTON FIRE DISTRICT'S INSPECTION BUREAU TO CONDUCT LIFE SAFETY INSPECTIONS IN ACCORDANCE WITH THE "KENTUCKY STANDARDS OF SAFETY" (CHAPTER 10 TITLE 815 KENTUCKY ADMINISTRATIVE REGULATIONS), AND TO ISSUE THE PERMIT UPON SUCCESSFUL INSPECTION.
