MUNICIPAL ORDER 2025-05 - A MUNICIPAL ORDER OF THE CITY OF WALTON, KENTUCKY, AUTHORIZING THE CITY TO PROVIDE A PORTION OF ITS FUNDS OBTAINED FROM THE NATIONAL OPIOIDS LTIGATION SETTLEMENTS TO THE WALTON FIRE PROTECTION DISTRICT TO BE USED TO COMBAT AND REMEDIATE THE EFFECTS OF THE OPIOID CRISIS IN THE CITY.

First Reading – Ordinance 2025-18 - AN ORDINANCE OF THE CITY OF WALTON, KENTUCKY, AMENDING SECTION 72.01 OF THE CITY OF WALTON CODE OF ORDINANCES, ENTITLED LIMITATIONS ON STOPPING AND PARKING, IN ORDER TO PROVIDE THAT THE MAYOR, IN ADDITION TO THE CITY COUNCIL, MAY DESIGNATE A LIMITED OR NO PARKING AREA, AND CAUSE TO BE ERECTED SIGNS OR CURBS PAINTED IDENTIFYING SUCH PARKING AREAS.

Council member Amy Long made a motion to approve the first reading of Ordinance 2025-18. Council member Dan Martin seconded the motion. Upon roll call the following members of council voted “yes”: Dan Martin, Caleb Flege, Sherry Gaskill, Amy Long and Rose Beach.

First Reading – Ordinance 2025-19 - AN ORDINANCE OF THE CITY OF WALTON, KENTUCKY, AMENDING SECTION 92.16 OF THE CITY OF WALTON CODE OF ORDINANCES, ENTITLED RUBBISH, IN ORDER TO EXPAND THAT TITLE TO INCLUDE EXCESSIVE GROWTH OF WEEDS AND GRASS, AND TO PROVIDE THAT A CITY REPRESENTATIVE MAY GIVE NOTICE OF VIOLATIONS AND TO ALLOW THE CITY TO REMEDY THE SITUATION IF THE OWNER OR AGENT OF THE PROPERTY FAILS TO DO SO, TO CHARGE THE OWNER FOR THE WORK, AND TO FILE A LIEN IF NOT PAID.

Council member Dan Martin made a motion to approve the first reading of Ordinance 2025-19. Council member Rose Beach seconded the motion. Upon roll call the following members of council voted “yes”: Dan Martin, Caleb Flege, Sherry Gaskill, Amy Long and Rose Beach.

Municipal Order 2025-06 – A MUNICIPAL ORDER OF THE CITY OF WALTON, KENTUCKY, REAFFIRMING WITH MODIFICATIONS THE MORATORIUM ON NEW CONSTRUCTION IN THE WALTON WATER AND SEWER SERVICE AREA WHICH WAS INSTITUTED BY MUNICIPAL ORDER 2024-08 ON July 9, 2024, UNTIL NEW FACILITIES ARE CONSTRUCTED TO IMPROVE THE CAPACITY AND PERFORMANCE OF WALTON'S WATER DISTRIBUTION AND WASTEWATER TREATMENT SYSTEMS.

Council member Dan Martin made a motion to approve Municipal Order 2025-06 with the amendment that the City Engineer and the City Administrator finalize the approval.
